- Items received from sponsors:
 - Academy floating key chains
 - o 500 SureLife mini bottles of tank release treatment
 - o Fun and Sun purchasing drawstring bags to put everything in
- Food items and ideas
 - Money voted on and set aside from last meeting to go towards food
 - Remaining money from allocated to state tournament go towards catering for Friday night since restaurant options are very limited in Sam Rayburn area
 - Johnny's Catfish from Shreveport: Fried Fish, Chicken Strips, Fries, Hush Puppies,
 Coleslaw, Tea, Plates, Silverware, Ice, All Condiments (\$13 per person).
 - Setting aside additional money from carryover to cover remaining catering costs, but will be checking with sponsors to see if any will want to assist with costs, and also considering setting up a donation location for angler families to contribute to.

Steve Holland made a motion to use the Johnny's Catfish catering company to feed 1,000 people on Friday night check-in, Ryan Emmert 2nd. Motion passed.

- Reviewed design options presented by Matt Tolnay.
 - Roman Numeral Design selected
 - Fish will be made a little larger on logo
- Plastic covering will be made to go over podiums with 10 yr logo
- o Big checks will be made with 10yr logo as well
- Logo to remain gold on the plaques
- o Trademark needs to be added to the 10 yr logo

6) Discuss carryover funds

- Money remaining (not including merch sales for regional and state)
- Set aside \$5k for carryover into next year per allowances for 501c3
- \$4,000 additional towards state scholarships

Tim Haugh made a motion to add additional \$4,000 to state scholarships from the carryover funds, Riley Fitzgerald 2nd. Motion passed.

7) Discuss New Trailer

- o Listing old trailers for sale, and amount for each
- Use the amount received towards a downpayment for new trailer
- o Do not order new trailer until old ones sell so we can remove insurance from old trailers
- Decision made: sell Riley's current trailer now, use proceeds as a down payment for a
 new trailer and start the building of said trailer. He will take Matt's old trailer until we
 can determine how much additional revenue we will have from merch sales to
 potentially pay off new trailer. Once new trailer is received for Riley, we will sell Matt's
 old trailer and use those proceeds to as a down payment towards a new trailer for Ryan.

Tim Haugh made a motion to approve new trailer transaction (see decision made notes on previous page), Audrey Tolnay 2nd the motion. Motion passed.

8) Discuss 2023-2024 Schedule

- Anthony Davis reviewed the proposed schedule with the board.
 - o 22 Academy Check Ins
 - New lake added to the 2024 spring schedule for North and Northeast divisions, and can be changed if Lake Bois D'Arc is still not open
 - o Rayburn has already been booked for 2023-2024 season
 - Discussed Caddo and additional insurance policies we must get if weigh in is in Louisiana since there's not a good option for weigh-in in Texas. (Not too much more than rental fees we have to pay to use other weigh in sites at other lakes).
 - LBJ and Canyon will have to have weigh-ins at schools or off site locations due to marinas not being large enough to accommodate our divisions.
 - Changing LBJ to Belton to have larger weigh-in location (Belton will create an additional Academy check in)
 - o Monitoring Brownwood levels through the year just in case it needs to be moved
 - Removing Lake Livingston and adding Lake Houston for Bayou City division (that will add an additional Academy check-in), and switching the dates (Lake Houston on 10/28, and Somerville on 03/16)

- o 24 Academy check in's with updated lakes
- Flipping dates for Texoma and Eagle Mountain for Metroplex (Texoma on 02/17, Eagle Mountain 09/30)

Audrey Tolnay made a motion to approve 2023-2024 schedule, Anthony 2nd motion. Motion passed.
